### Return SEC Member Proxy Card and Become Eligible to Win \$500 Free Electricity

SEC members can find the postage-paid, self-addressed Proxy Card on the upper portion of the back page of the dust cover of this month's *Cooperative Living* magazine. Members should simply tear off the Proxy Card along the perforated area, fill out and sign the card, and return/mail it to the Cooperative. Members who sign and return the Proxy Card to SEC's office by 5 p.m. on Friday, Sept. 23, 2016, will be eligible to participate in a drawing for a chance to win \$500 towards their electric bill. The Proxy Card should be signed and returned even if you plan to attend the annual meeting. When a member registers at the annual meeting, the proxy that has been executed by him/her becomes invalid, and the member in question is entitled to vote on all matters that might take place in the same manner as if the proxy had not been executed. Returning the proxy also helps to ensure that a quorum is present at the annual meeting.

#### Three (3) Directors to Be Elected

Highlighting the business session of the 79th Annual Meeting of Southside Electric Cooperative will be the election of three (3) persons to serve on SEC's Board of Directors to represent Districts I, II and III of the Cooperative's service area. As your elected representatives, the Board of Directors conducts the business affairs and establishes overall policies of the Cooperative. Members are also provided information about the financial health of the Cooperative, along with a progress report of ongoing and future activities and programs.
